### **President's Column**

Fellow Members,

2022 has drawn to a close, and 2023 is upon us.

We ended 2022 with a profitable balance, even after internal investment in our rehearsal hall and infrastructure. We've increased the visibility of our local with over 130 public access (free!) performances by our members across Metro Louisville in addition to adding art to our neighborhood with our mural on the outside wall of our rehearsal hall.

We would not be here without you, our members. We increased total membership in 2022 ending the year with 315 members.

In 2023, our focus will be growing membership by attracting younger musicians. The majority of our members are over 50: this is not self-sustaining business model for a number of reasons. However, there is a wealth of musicians across our city who are unaware of the purpose of labor unions; rarely do college students know of the seminal events in labor struggles: the American Railway Union strike of 1894 against the Pullman factory, or the Triangle Shirtwaist fire of 1911, These are events which shaped national labor policy protecting workers instituting collective bargaining (rights eroded by conservative politicians wishing to eliminate those worker protections).

In unions, workers use collective bargaining to meet management on an equal footing, able to negotiate fair labor contracts for fair wages, benefits and care and consideration upon retirement.

In the words of George Santayana: "those who cannot remember the past are doomed to repeat". If you aren't aware of my historical references above, please google them. It is a visceral reminder of the history of the labor movement, and the negative consequences in the absence of worker protections.

Don't forget to renew your membership and put our next quarterly meeting on your calendar: Monday night, Feb 20<sup>th</sup> at 7:00 PM in the rehearsal hall.

To entice membership attendance, we will have pizza. What musician can resist a free meal?

#### In Memorium



James A. Rago, 79, passed away October 13, 2022. Jim was born in New York and grew up in Lyndhurst, New Jersey. He moved to Louisville, Kentucky in 1967 having been recruited by Jorge Mester, then conductor of the Louisville Orchestra. Jim performed as Principal Timpanist for orchestra from 1967 – 2022. He was the longest-

tenured current member of the Orchestra, having performed for 55 years.

Jim graduated from Lyndhurst High School, New Jersey, and entered The Juilliard School of Music in 1961, graduating with a master's degree in 1967. He studied percussion under the acclaimed Saul Goodman, who revolutionized the design of the timpani and the art of playing, and Anthony Cirone, past Principal Percussionist with the San Francisco Symphony. Jim performed at the Aspen Music Festival for many years. He was a consummate professional with exceptional musicianship, who taught a generation of students as a professor of music at the University of Louisville for 30 years. He especially enjoyed jazz and the big band sound, but classical music was his passion. His philosophy of life was to be patient, work hard and you will find your place.

Jim's life of giving musical gifts to the Louisville community will be greatly missed. He is preceded in passing by his parents, James Rago, Sr. and Helen Puntilillo Rago. He is survived by his loving wife of 29 years Cheryl Rago, his children Angela Gordon (Ron), Susan Epps (J.R.), Carole Jenkins (David), Jeff Maddox (Patti) and Amy Stewart (Tony.) 

### **REHEARSAL HALL POLICY**

\*The Rehearsal Hall is booked on a first-come-first-served, month-by-month,/ 4 week basis by phoning or emailing the Office Manager at 451-7509 or <u>musunion@louisvillemusicians.org</u>. Please contact the office towards the end of the month to book for the next month - or, as soon as you know when you'll want the room. Please note: Bookings are not firm until a confirmation e-mail or phone call is received from the Office Manager. Once confirmed, the code for the key lock box may be obtained from the office during regular business hours Monday through Friday (11 am - 2 pm).

\* Bookings may also be made via the On-Line Self Scheduling Calendar link in the "Members " section of the website, www.louisville musicians. Org (a Local website username and password are required, contact the Office if you need one).

\* Keys are to be returned immediately following use. After hours, please return the key to the lockbox (located on the side door between the hall and Murphy's Camera Shop) so that it is available for the next person.

\*Only members in good-standing may book the Rehearsal Hall, and all members of the group rehearsing must also be members in good-standing. Exception: Member ensembles auditioning new players, who may or may not be members, may book the hall. Use of the hall for auditioning new players is limited to three times per vacancy. Please notify the Office Manager of this situation at the time of booking. Please note: In these cases, the member booking the hall should take every opportunity to extend an invitation to any non-union player(s) to join the Local. Other exceptions to this policy will be considered on a case basis. Please contact the Office if you have any questions or concerns.

\*Although its primary use is for musical rehearsals, members may also use the hall for other types of events, with prior approval of the Executive Board (e.g., gathering of non-musical friends, etc.). Contact the Office Manager to submit a request.

\*The Rehearsal Hall is not for storage of personal equipment. Members are asked to remove their equipment when done, and return the room to its original ready-to-use condition.

\*The Local is not responsible for any theft or damage of items left in the room.

\*There is absolutely NO smoking in the building or use of any flammable items of any kind (e.g., candles and incense) due to Fire Department Regulations, members' allergies and common courtesy. Cigarette butt disposal containers are located outside each door.

\* Alcoholic beverages are not allowed in the Rehearsal Hall due to insurances restrictions.

\*Dispose of all trash before leaving the Rehearsal Hall. Trash bins are provided at each end of the rehearsal room and a recycling bin is located near the kitchen. Please empty all liquids from containers before depositing them in the trash/ recycle bins. Please carry large volumes of trash out to the black garbage cans at the end of the parking lot.

\*Please turn OFF all lights and return the thermostat to its "normal" setting before you leave. By pressing the "run Program" button on the thermostat. NEVER turn the thermostat to the "off" position.

\*Please ensure all doors are securely shut and locked when you leave.

\*Please notify the Office Manager of any issues with the Rehearsal Hall (e.g., non-functioning HVAC, paper towel replenishing, non-functioning lavatories, etc.)

## THE QUENTIN K. SHARPENSTEIN FUND

In 2018 Local 11-637 saw the passing of Quentin Sharpenstein. Much beloved, Quentin left a wonderful legacy as a musician, contractor, teacher, and leader in our own organization and in the Louisville community as a whole. Because of his dedication to our Local, his widow Paula asked if we would accept donations in his name to be used as we saw fit to honor him in some way.

The board investigated various possibilities and have established an endowed scholarship in Quentin's name to be awarded to a deserving student of the low brass family at YPAS, identified by the YPAS faculty and Administration.

Your annual dues don't go as far as you might think! For AFM Regular members who pay \$150 in annual dues, only **\$51.82 remains in the Local coffers**. This is due to the following obligations - deductions for the life insurance policy (22.68), AFM per capita dues (\$66), KY AFL-CIO dues (\$7.20), AFM Southern Conference dues (\$.50), and Greater Louisville Central Labor Council dues (\$1.80). For AFM Life members, the Local Office's net revenue is **\$33.54** after life insurance (22.68), AFM Per Capita (\$40), KY AFL-CIO (\$7.20), AFM Southern Conference dues (\$40), KY AFL-CIO (\$7.20), AFM Southern Conference dues (\$40), KY AFL-CIO (\$7.20), AFM Southern Conference dues (\$1.80). This is why work dues are CRITICAL to the functioning of the Local!

# Do You Know Someone Who Should Be in the Union?

## If you're working, teaching, or just hanging with other musicians chances are you know someone who *should* be in the union —*but isn't*.

That's the way the business is today. Too many musicians are working outside the union, missing out on the advantages of AFM membership. They don't enjoy true contract protection. They don't have easy access to job referrals, reliable booking agents, recording and multimedia protection. They don't work under collective bargaining agreements. They're not part of a community of musicians that works to make the music industry better and fairer for musicians.

### They don't know that "Membership Makes the Difference."

### That's unfortunate for them. And for you.

As an AFM member, you know your real strength in the music business comes from working collectively with other musicians. Isolated musicians are more easily exploited and less likely to receive benefits that union musicians take for granted—contracts that are more than just pieces of paper, scale wages worthy of professionals, respect and dignity.

Although they don't mean to, non-members hurt all musicians by remaining outside the union. They convince the people who hire us that musicians have low standards, that we're willing to settle for less, that we're not serious about our profession.

The best way we can build a better music business is to build the union by bringing non-members into our Local. It's easy. Any member *can* do it. Every member *should* do it. Just talk to the non-members
